Greetings from the Mount Vernon Dan Emmett Music & Arts Festival 2017!

The Dan Emmett Music & Arts Festival in downtown Mount Vernon, Ohio is full of music, food, arts, classic cars and more! The 2017 activities are Thursday, August 10 - Sunday, August 13. We hope you will find the events related to the arts a fun and rewarding experience for you. In addition to the following general guidelines, you will also find a 2017 application.

This show operates on a First-Come, First-Serve basis. There is no seniority for Fine Artists, Crafters or Commercial Trades who have participated in previous Dan Emmett Festivals. The deadline for all entries is July 31, 2017. Our booth space is limited to 120, so the best way to assure your participation in the festival is to return your application and payment EARLY. Please be aware that we try to create a balanced show. Because of the large number of crafters offering jewelry, we will be selective and look at the submission date to determine participation. APPLY EARLY.

This year's show will be divided into four categories; Fine Arts, Crafts, Trades, and Kid's Activities. Your description of your products and photos will help us determine the classification and booth area you will be assigned. Please understand, only the items listed on your approved application will be permitted for sale. A festival participant not adhering to this understanding will be asked to leave the show. Entry fees will not be refunded.

PRODUCTS - Fine Art, Crafts:

Please submit full descriptions and photographs of all products to be sold. (Photos will be returned in registration packets). This applies to both new and returning participants. If you sell a product not listed on the application, you may be asked to withdraw the product from sale. It is important that products are pre-approved so that we do not place two like-products beside each other. Within the space allocated for the show, we try to offer visitors a diverse selection of products and avoid having a glut of one product, hurting the sales of each exhibitor of like products. You may not sell or freely distribute any food or beverages, including bottled water. This would place you in competition with the food vendors, who pay a higher fee for the privilege of providing food and beverages, and who are licensed and inspected by the Knox County Health Department.

APPLICATION/CONTRACT ACCEPTANCE:

Vendors who are accepted will be notified within 7 days of application submission. Anyone not accepted by the Dan Emmett Music & Arts Festival will be notified within 7 days from the time your entry and contract was received.

SET-UP/Take Down:

- All participants will be permitted to load in, no earlier than, Wednesday Evening, August 9th, from 7:00 to 10:00 pm. or Thursday Morning, 7:00 to 11:00 am. All booths are to be completed by 11:00 am on Thursday, August, 10th. No Exceptions!
- All Booths must be removed from the premises by Saturday evening by 11:59 p.m.
 - Main Street and side street vendors may begin “Take Down” when the headliner begins their show. Artists on the Square may begin “Take Down” at the conclusion of the headliner’s performance.

EQUIPMENT/SUPPLIES:

- Tables, Chairs, Tents, Canopies, lights, extension cords etc. are the responsibility of the festival guest.
- All tents/booths will be on asphalt surfaces.

DOWNTOWN VENUE

The entire area of the festival is kept within the city square area, including three blocks south of the square. Vehicle and overnight camping are not permitted in the downtown area. Pets and alcohol are prohibited. A map and information about hotels, and campgrounds in the area will be sent, if accepted and requested.

BOOTH SIZE

Exhibitors will be allotted booth spaces as described in the fee description. Canopies, tents, tables or other objects or structures used must fit into the allotted area. If festival exhibitors exceed the specified area, an additional charge will be assessed. **All vendors must have suitable and functional weighting methods for securing their canopy and materials. Approval of tents or booth coverings is at the discretion of the festival coordinators to provide safety for participants and those attending the festival. Event organizers reserve the right to disapprove tents or booth coverings and deny permission for set up or require the removal of unacceptable tents or coverings.**

CRAFTER HOURS:

Hours are from 11:00 am. 9:00 pm. See festival schedule for specific times. All vendors/crafters must keep their booths intact for the duration of the festival. Permission for a crafter to leave early will be granted only in a medical or emergency situation. Any exhibitor leaving without permission from the Dan Emmett Music & Arts organizers will not be accepted for any future shows.

FEES & ACCEPTANCE:

- Fine Arts / Crafters/ Kid’s Activities /Vendors:
 - All booths are \$100.00 for the three day show.
 - Each Space is 10’ x 10’
 - Electric is available, but limited for the Fine Art exhibitors on the square.
 - Electric is available for all booths on Main Street and Side Streets
 - If electric is needed there is an additional \$10.00 charge.
 - Exhibit days...Thursday, August 10 / Friday, August 11 / Saturday, August 12
